## **REQUEST FOR BIDS**

Sealed bids will be received until 9:00 a.m., Wednesday, March 7, 2018, at the office of the Kalkaska County Road Commission, 1049 Island Lake Road, Kalkaska, MI 49646, for furnishing the following:

### **2018 SEASONAL REQUIREMENTS OF BITUMINOUS PATCHING MATERIAL AND PLANT MIX ASPHALT TO BE USED AS PATCH MATERIAL**

Bids must be submitted on the Road Commission's bid form. Bids need to be received in a clearly marked sealed envelope stating "BITUMINOUS PATCHING MATERIAL BID". Bids will be opened at a regularly scheduled Finance Committee meeting on Wednesday March 7, 2018 at 9:00 a.m. Awarded bids will be approved at the regularly scheduled board meeting on Tuesday, March 13, 2018 at 9:00 a.m.

Past records reflect approximately 1,000 tons of Bituminous Patching Material used in an average year.

The bidder shall include in this proposal a mix design showing the materials used and percentages of each. More than one mix design may be submitted if desired.

Separate bid prices shall be given for the material to be picked up by Road Commission trucks at the plant and alternate bids for the material FOB Kalkaska County Road Commission garage at the above address in 50 ton loads within 72 hours notice (see attached bid sheet).

Other grades of patch may be considered and shall be included as an optional bid. Items bid on must be available from May 1 through October 31 at the bid price unless otherwise specified on bid sheet.

The Kalkaska County Road Commission reserves the right to accept or reject any or all bids, to waive any irregularity or defect in a bid, or to accept that bid which in the opinion of the Road Commission is in the best interest of the county. Kalkaska County Road Commission will not accept invoices containing fuel surcharges or additional charges that have not been approved by the Kalkaska County Road Commission.
